Annual Meeting Rules and Procedures

*C8.02 Members shall be classified as follows:

- a. Baptized members are those persons who have been received by the Sacrament of Holy Baptism in this congregation, or, having been previously baptized in the name of the Triune God, have been received by certificate of transfer from other Lutheran congregations or by affirmation of faith.
- b. Confirmed members are baptized persons who have been confirmed in this congregation, those who have been received by adult baptism or by transfer as confirmed members from other Lutheran congregations, or baptized persons received by affirmation of faith.
- c. Voting members are confirmed members. Such confirmed members, during the current or preceding calendar year, shall have communed in this congregation and shall have made a contribution of record to this congregation. Members of this congregation who have satisfied these basic standards shall have these basic standards shall have the privilege of voice and vote at every regular and special meeting of the congregation.
- d. Associate members are persons holding membership in other Christian congregations who wish to retain such membership but desire to participate in the life and mission of this congregation, or persons who wish to retain a relationship with this congregation while being members of other congregations. They have all the privileges and duties of membership except voting rights and eligibility for elected offices or membership on the Congregation Council of this congregation.

C10.04 Sixty (60) voting members shall constitute a quorum.

C10.05 Voting by proxy or by absentee ballot shall not be permitted.

C10.06 All actions approved by the congregation shall be by majority vote of those voting members present and voting, except as otherwise provided in this constitution or by state law.

C10.07 Robert's Rules of Order, latest edition, shall govern parliamentary procedure of all meetings of this congregation.

Adds language regarding the process of issuing a calling of a Deacon and describes the qualities, job description and other contractual duties and rights of both Deacons and the congregation they serve. Chapter 16 - BYLAWS, Chapter 17 - AMMENDMENTS (change of numbers to match the model constitution and chapters 10, 16 and 17 (authorizing electronic communication between congregations and membership) were combined into one motion to approve by Dan Weber, 2nd Judy Zwart, motion approved.

Senior Pastor's Report—Rev. Marie AK Anderson

This is the 6th annual report I've written for Saint Paul. Each report started with a different year in the following sentence: The year 2023 turned out to be as full of change, challenge, and celebration as the other years I have served God as your pastor. The preceding sentence should be true of a congregation where God and God's people are being served. Celebration was by far the highlight of 2023 with a few changes, and challenges too.

The life of a congregation is lived out in four ways: through Worship, Education, Service and Fellowship. Throughout 2023, we celebrated all that God has done through and with the members of Saint Paul for 125 years. We celebrated using each of the four expressions of being congregation.

WORSHIP: Thanks to a dedicated group of volunteers Sunday, Lenten, Advent, and Festival worship services were live streamed. The sacrament of Holy Communion was celebrated twice a month and at Festival worship services. 11 baptisms, including two confirmation students were celebrated in 2023. The gospel was faithfully preached by several pulpit pastors and myself. We look forward to the time when the numbers in worship lead to the return of a midweek worship service year around and two Sunday morning worship services.

Many of the 125th anniversary celebrations had a component that happened in worship. The first 125th anniversary event was held on the Sunday the ELCA celebrates the Baptism of Jesus in January. That worship service included two baptisms, the opportunity for all members to reaffirm their baptism and was attended by oldest member baptized at Saint Paul. Former pastors came to share a gospel message and memories. The oldest returning pastor was 92. It had been so long since he had been invited to preach anywhere that his wife chose to buy him a new clergy shirt for the occasion. When All Saints arrived, we remembered the saints from Saint Paul who had entered eternal life in the past year as well as all 828 members who became saints in the 125-year history of this congregation. As part of the 125th anniversary we celebrated marriage, WELCA's work, confirmations, and many other things.

EDUCATION: Sunday School attendance continues to grow under the leadership of Emily O'Brian the Sunday School administrator. She introduced a Fall stewardship event to Sunday School and provides an opportunity for students to give a weekly offering. From my unique point of view, I get to see the Sunday School students rushing down the center aisle to bring their offering to the altar. The changes to the Confirmation curriculum last year are bearing fruit. Students enjoy the accountability and compete to show how much they have learned through accumulating points. Students have asked for clipboards to make note-taking in worship easier. Clipboards have been ordered. Adult education has begun offering Sunday morning forums during coffee hour with exciting speakers. Milestone Ministries continue to be an important part of congregational life. The best attended of the several milestones offered in this congregation is the preparing for Holy Communion class. The class is offered to third grade and older students who have not taken the class. With the help of Ms. Mentjes, the High School art teacher, the students make a pottery cup to be used the first time they take part in the sacrament.

As part of the 125th anniversary, we learned about the Apostle Paul, for whom our congregation is named, the work and contributions of WELCA and its predecessor organizations, what language worship was held in when this congregation began, (German) and the variety of missions supported in person and through offerings.

SERVICE: Saint Paul has a long tradition of service locally and globally. In 2023 quilts were donated to the newly baptized, High School Seniors and local organizations. A great, numerous, diverse, beautiful, and generous quantity of quilts were created and distributed. A dedicated team worked on the local Habitat House which was turned over to a Saint Paul family when it was finished. It included a new washer and dryer donated by Saint Paul Lutheran. Youth worked at Feed My Starving Children on an early release day, under the leadership of Youth Ministry volunteers. While there are always people struggling to feed themselves and their families, the numbers have increased in the past year. Saint Paul

has always been generous in donating to the local Sharing Shelves. In 2023 as part of Thanksgiving offerings, a parade of food was held which resulted in 190 pounds of food being donated. Toilet paper is always needed at the Sharing Shelves, so we are striving to become known as the toilet paper congregation. People serve through Saint Paul Lutheran, in the community and around the world in so many ways.

A signification effort was made to identify all the ways Saint Paul Lutheran has engaged in Mission Support (a kind of service) throughout 125 years of existence in this community. I wonder what our descendants in faith will report about our service and mission support in another 125 or 50 years.

FELLOWSHIP: Of course, we are good at this and here are a few highlights. There are always people to pick up donuts or cookies, serve them and clean up on Sunday mornings. The overflowing tables of food at pot-luck dinners testify to a desire for congregation members to spend time together. The Saint Paul bowling teams joined together for a second season. Many returning people as well as new ones are bowling every other week. Bowling is our most successful inter-generational event. There are four students, a few over 70 and lots of us in between. There are so many ways that Saint Paul members gather in fellowship outside of the church sponsored events. People sit together over cards, sports practice and events, backyard parties and while at work.

The 125th anniversary Block Party was the focus of fellowship for the year. Planning started early in the year and continued until hours before the event started. So MANY members volunteered and even more showed up to have fun. Music, Food and Fun of all sorts were available. Just days before the Block Party the summer long drought ended with a forecast of rain for a week or more. We prayed even more for good weather for the day's events. The rain stopped early enough in the morning for the final set up to go ahead and did not start again until most outdoor activities were over. The food and music moved indoors and the celebration continued. The next day our bishop, The Rev. Regina Hassanally joined us in worship in a building and sanctuary all clean and tidy.

Council President—Doug Strandell

What a year we have had in 2023. It has been great to celebrate the 125th Anniversary of Saint Paul Lutheran. We could not have made this celebration happen without the many volunteers who donated their time and talents. A special thanks to Steve Pleschourt for his wonderful leadership and coordination.

2023 has also been a year in which we are seeing growth in our congregation through programming, attendance and financial support. We have ended 2023 in the black. You may remember that last year our church staff agreed to a pay freeze which was an amazing sacrifice on their part and helped our financial situation. Thankfully, due to your generous giving, late last summer the council approved a 3% increase to their 2023 salary for the remaining 4 months of the year based on our financial situation at that time. Thank you, members, for your fiscal support.

Your church council has been working hard to study and discuss the ways in which we can continue to improve our church program and experience. Much of our discussion has been related to staffing. Moving from two clergy to one pastor has been challenging. Pastor Marie has worked hard and we should all be thankful for her extra time and effort to provide leadership for our congregation. The council has also discussed ways in which we could possibly add a person to work with our middle and high school youth. This dialogue will continue in 2024.

Along with staffing our building and grounds council representatives, along with their committee members, have designed and priced out some needed updates to our facility. The plans were presented to the church on Sunday, January 7. More information will be coming out in the future. These projects are being funded by your donations that have been made in honor of our 125th anniversary. Thank you, donors, for your abundant generosity.

Thank you to our members, staff, volunteers, and church council for all you do to assist our church and its mission. As I look forward to 2024 I am optimistic for our congregation. We can all remember the times not so long ago when Saint Paul Lutheran had more staff, more programming, a larger budget, multiple services and higher attendance. We are not alone in this experience. COVID, society, inflation and many other challenges have had an impact. However, we are still here and 2024 is ahead of us. We must remember to give thanks for God's love and redeeming grace. May the Holy Spirit help and guide us into our future and continue to inspire our members and staff to "welcome, love and work for God's people here, there and everywhere."

Building & Grounds—Dan Weber & Fred Knudsvig

The Buildings and Grounds Committee had to perform and contract several repairs throughout the year. The first major repair was a tear in the roof that resulted in water leaking into room E in the education wing. One of the basement sump pumps failed and needed to be replaced this Spring. Two flush values in the men's and women's bathrooms also had to be replaced. These repairs consumed 80% of our annual budget.

Spring clean up was held and all green areas and flowerbeds other than the East lawn outside the education wing were raked. Additional plants were planted in the East flower bed along the education wing and fresh mulch was brought in for both East facing flower beds before the 125 Anniversary. Depressions in the East lawn outside the education wing were filled and leveled with black dirt.

Access of the organ was improved by shortening the back pew and reducing the riser to the balcony floor. This improvement allowed for direct access to the organ from the top of the stairs without having to walk around all three sets of pews and bell choir tables.

Several external door locks were replaced and a new key / access management process was put in place as there was no record of whether former members had returned issued keys and a number of undesirable events had been occurring in the early months of the year.

Six families kept the lawn trimmed throughout the summer - Weber, Knudsvig, Barsness, Toft, Anderson, and Gadsen.

Six additional exterior power outlets were installed on the west side of the church to accommodate the various electrical devices that were planned for the 125th Anniversary block party. The resulting inspection of the existing electrical discount box revealed both main power conduits had sunk over time which resulted in a gap between the conduits and the bottom of the electrical box.

The conduits had to be uncovered resulting in a trench 3 feet deep and 10 feet long so the conduits could be raised back to their original position. Bracing was added to the bottom of the conduits to support them better and the conduits reburied.

Leaves were collected and taken to the dump on multiple occasions during the fall to keep the South and Entrances unencumbered.

Several repairs were made to the Southeast rental unit after the tenants moved out in November.

Worship was held on Palm Sunday @ 9am, Maundy Thursday and Good Friday @ 6:45pm, and 2 services on Easter at 9 & 10:30am.

Christmas Worship

Thursday, Dec. 21, Daylight Service was held at 11am with a noon meal following worship.

Christmas Eve, Dec. 24 offered 3 worship services @ 3, 5 & 10pm.

There was no worship on Christmas Day, Dec. 25.

Throughout the year, Myra worked closely with Pastor Marie planning these worship services. After that, she prepared the seasonal worship masters that included the information the PowerPoint team used to prepare the weekly worship slides. Myra also coordinated the PowerPoint team schedule.

Youth Education—Jeff Schroeder

Early in 2023 Chelsey Haugen stepped down as director of youth education. The position was taken by Emily O'Brien. The spring Sunday school classes were split into two sections; three years old through first grade and second grade through sixth grade. Vacation bible school was held during the summer.

Fall Sunday school began with 42 children signed up. Classes were broken up into the same two sections. The young people held a fall pumpkin and gourd sale with the proceeds turned over to the food shelf. Attendance averaged between 25 and thirty students through the fall. The inter-generational advent project was well attended with many age appropriate crafts and a family photo opportunity.

Cradle Roll—Diane Webb

Children become a part of Saint Paul Lutheran's Cradle Roll program when they are baptized, and the final mailing is sent at the third birthday. At that time they are invited to begin taking part in our Faith Formation program. We continue to use *Splash* materials published by Augsburg Fortress for our Cradle Roll families. They receive monthly newsletters to help them incorporate faith formation into the events of their daily lives with Bible stories, prayer, worship, and devotion times. Eleven children were added to the program in 2023.

Evangelism—Eric and Tracy Barsness

4 families joined Saint Paul Lutheran in the fall. A class was held for new members the week preceding the new member service.

125th Committee—Steve Pleschourt

Throughout the 2023 year, the congregation celebrated the 125th anniversary of Saint Paul Lutheran Church. Themes for each month were determined and focused on the history of Saint Paul Lutheran relative to: Baptisms, the missions of St. Paul the person, Weddings, Sunday School, Quilting, Cheese Fest, Outreach, Confirmation, All Saints, and Christmas.

In September a block party was held that included things like a car/tractor show, concessions, kid games, raffles, bean bag tournament, bingo, a petting zoo, and featured the Rochester Big Band sharing their big band music. Proceeds from the block party of approximately \$5000 were given to the 125th Anniversary fundraiser which raised almost \$25,000 to be used for improvements to the church.

During these visits the congregation had the opportunity to visit and reminisce with pastors who preached going back almost 60 years. 2023 Rental Property Report—Eric Barsness

Saint Paul Lutheran has purchased neighboring properties over its history to enable growth, such as the main west parking lot and the 2003 classroom addition. At this time, the congregation owns four neighboring houses which are managed by a rental management company. Those houses are:

- 217 2nd St SW ("West Rental"), purchased in 1999
- 213 2nd St SW ("East Rental"), the former parsonage built in 1919
- 209 2nd St SW ("Northeast Rental"), purchased in 2020
- 208 3rd St SW ("Southeast Rental"), purchased in 2017

In 2023 the properties combined net income after expenses was \$27,643.78. This net income approximately covers the rentals' portion of the church's mortgage payment. Expenses for the rentals was higher than typical in 2023, mostly due to having to cut down two trees (including one very large ash tree) and removal of three stumps at 209 2nd St SW.

Future

The city is planning to redo 3rd St SW in front of the church starting in 2025. In line with our long-term design plan, the house at 208 3rd St SW would likely be removed at that time and the existing east (staff) parking lot expanded. This would add an estimated 15-16 off-street parking spots and improve access to the south doors (#1 doors). Doing the work in 2025 would avoid the street project hook-up expenses, reduce the street assessment cost to the church, and allow us to take advantage of discounted rates due to the street work.
